- Finances were discussed at the last Board Meeting. Based on this discussion, Robert Tear N9KGL presented an Expense Statement, showing that we would run out of money in about three years at our current rate of income vs. expenses.
- The proposed solution supported by the Board is to establish a 501(c)(3), referring to a section of the U.S. Internal Revenue Code that grants tax-exempt status to specific charitable and nonprofit organizations.
- Robert Tear N9KGL went on to explain it would cost about \$600 to set up, which the club can afford at this time. Fund raising could then be done. The money could come from grants or fund raisers such as a Fish Fry, Bar-B-Q, or Fireworks booth.
- Tim Hutchings N5TCH motioned to table the motion to set up the 501(c)(3) until the October meeting so more of the club could vote on it. Marlon Duckett KJ5ENR seconded the motion. Motion to table carried.
- Roy McCleary N5ZKW announced Charles is raffling off a 21 inch monitor to benefit the Club. The raffle will be during the October meeting.
